

#### **UTILITY INFO**

ELECTRIC:	23 kV line is adjacent to the property and 230 kV line runs within the property
NATURAL GAS:	4-inch line is adjacent to site and 6-inch line could be extended for heavier users
WATER:	12-inch line is adjacent to the property; line has excess capacity of 1.5 mgd and system has 3 mgd
WASTEWATER:	15-inch gravity line located within property; line and WWTP (located adjacent) have excess capacity of 5 mgd
TELECOM	Fiber is readily available

The age and income characteristics of the region are well aligned with the needs of manufacturing. This is due in part to the military base presence, which shows a favorable and median age profile below the state average. The relative demand data (jobs postings vs. occupational presence) are not inflated in the market, showing a relatively good balance of labor supply and demand. The community puts extra emphasis on reinforcing the pipeline, whether engaging students early in school or challenging emerging leaders to engage in the Central Carolina facility and training available.



### DUE DILLEGENCE

Phase I Environmental Site Assessment:	June 3, 2019	Phase I ESA was completed on 306.25 acres. One recognized environmental condition (small debris pile located on SW portion of property outside the development area) was identified. See report for full findings and details.
Cultural Resource Identification Survey:	May 2019	See reports for full findings. Cultural resource investigation was conducted on 320 acres, and intensive survey on 193 acres, which noted 7 previously recorded sites and no newly recorded sites. Project area contains 160.2 acres of area with low probability for additional cultural resources, and 159.8 acres of moderate to high probability. The White Cemetery as shown above on master plan in SE corner should be avoided.
Boundary Survey:	November 21, 2008	Boundary Survey can be provided upon request, which captures easements and site conditions.
Protected Species Assessment:	June 7, 2019	Study found six (6) protected species listed for Sumter County and indicated the site does not provide suitable habitat for the listed species, and that development should have "no effect" on these species.
Report of Preliminary Geotechnical Exploration:	October 15, 2008	Geotech report completed seven (7) borings and found the site to have a Seismic Site Classification of D.
Wetlands Delineation:	June 6, 2019	Wetlands Delineation found that property contains five (5) jurisdictional wetlands totaling approximately 39.84 acres.
US Army Corp of Engineers Jurisdiction Determination Letter:	June 6, 2019	Approved Jurisdictional Determination Letter request submitted on June 6, 2019.
